## **Environmental Management**

- Comply with relevant legislation, client and other requirements that apply to all our work activities as a minimum.

- Identify and implement the training needs of all our employees, subcontractors and suppliers to raise environmental awareness across the business.

- Use registered waste disposal companies for the removal of all waste streams.
- Always maintain high standards of cleanliness in respect of litter and waste packaging.

#### **Energy**

- Support and facilitate the reduction of greenhouse gas emissions (such as CO2) by encouraging energy conservation and renewable energy generation.
- To control our energy consumption by reviewing and improving our purchasing, operating, motivation and training practices
- Monitor energy usage through accurate monthly consumption data.
- Communicate the energy used and improvement measures to all staff on a regular basis.
- Set and publish energy saving targets through annual targets.
- Provide annual management reports on consumption.
- Comply with all legislation, standards and practices relating to energy use at both a company and individual level.

### **Renewable Energy**

- Increase the proportion of energy from renewable sources used within the Company.
